



EPA enforces federal clean water and safe drinking water laws, provides support for municipal wastewater treatment plants, and takes part in pollution prevention efforts aimed at protecting watersheds and sources of drinking water.

These permits establish specific discharge limits, monitoring and reporting requirements and may also require these facilities to undertake special measures to protect the environment from harmful pollutants.

VICE PRESIDENT, LEGISLATIVE

Good day Chicago Chapter.

There is no news yet regarding the new codes, just that they are not published or enforced yet. During the summer there were a lot of schools that got remodeled; this is always a special challenge due to the abundance of people that define the scope of work. Everything starts with a wish list that gets reduced by

budget and then changed by unforeseen field conditions. Bringing toilet rooms and drinking fountains to meet code requirements is not complicated at all, but laboratory and work rooms is another story...


Let's talk about the Chemistry laboratory Rooms.

Emergency (EM) Showers (SH):

- a. Only required were acid substances are handled (i.e. Chemistry Labs, not Science Labs).
- b. Chicago Public Schools require an emergency shower with an integrated wall recessed eye wash station (EW). Coordinate with electrical engineer for the installation of the required warning light that has to be located outside the room were the EM Shower is being activated.
- c. The EM SH/EW will deploy 20 GPM continuously until is manually stop or for 20 minutes (depending on owners requirements) therefore it is necessary to provide a floor drain capable of handling this load; I recommend to provide a floor drain coated to resist acid corrosion with a minimum top opening of 8" and minimum of 4"outlet with 3"V.
- d. The eye wash portion of the emergency fixture requires an independent 2"drain, this connection is NOT in the CPS standard details, (which are requires to be used for CPS work) therefore it has to be clearly specified on the drawings (standard size will be 2"outlet with a 2" vent for quick flow). Spilling this drainage on the floor surface to flow to the floor drain is not an acceptable installation.
- e. The EM SH/EW has to be provided with a fixed tepid temperature of 80 degrees Fahrenheit, that can be achieved with a thermostatic mixing valve or by using a dedicated water heater.

Work sinks:

- a. The sinks for schools are usually specified by the Architect or Lab consultant as part of an integrated epoxy counter top. However, if it was not, then we have to provide the information for the basin in addition to the standard water, and gas supply, and drainage connections. It goes without saying that the drainage piping is to be acid resistant (the blue pipe). For safety reasons, most schools work with acid solutions that their strength is being reduced to 1M (M =Molar, which is the equivalent of one gram dissolved in every liter of diluting solution, the diluting solution is defined by the substance to be used). All piping labeled as "Acid Resistant" will be able to handle this strength. If the design is for a college, hospital or industrial lab a different grade of acid corrosion resistance is required for the piping an fittings.
- b. Due to the nature of acid/or corrosive substances the recommended pipe joining method is <u>heat induced</u>. Another common joining method is by using no hub piping and fittings.
- c. A central or individual acid neutralizer (AN) is required for drainage with a PH less than seven. The acid neutralizers must be vented at the unit and at the outlet. In theory all waste after the neutralizer will contain a neutral PH of 7, but as a preventive measure keep using acid resistant piping throughout the entire horizontal section of the pipe until the waste/sanitary vertical stack is reached. Where labs are not used for long periods of time, and if a non-acid resistant pipe is used on the outlet of the acid neutralizer, the drainage piping can still be corroded by the waste of an poorly serviced or unmaintained AN unit.



- d. All faucets must be supplied with a backflow prevention device. Approve backflow preventers are directly depending on the local institution, and AHJ codes. The most common one is the atmospheric vacuum breaker. There are two types of vacuum breakers: elevated and faucet integrated. Faucet integrated is the most common used, but not approved everywhere. (Always check local codes).
- e. The most common faucet is the turret type with gooseneck and serrated outlet tip.

Additional optional Lab equipment or components:

Fume Hood: Most of the time this workstation will have an integrated sink.

• Solenoid Valves: Use for emergency shut offs on teaching institutions.

• Ice Machine: Provide backflow preventer at water feed & receptor for condensation.

• Dishwasher: Verify temperature requirements for this device.

Food Grinders: Mainly for hospital use, with both water and drain connections.
 Wash rims: Accessory used at floor drains in industrial & hospital applications.

Always keep in mind ADA requirements, and coordinate with other trades.


<u>IIT STUDENT CHAPTER</u>
