

April Meeting Technical Presentation: Advancements in Clean Agent Technologies

Presenter: John Cann with Minimax Fire Products

Agenda: The presentation will cover a general overview of clean agent systems covered in NFPA 2001, the pros and cons of each style, how pressure effects performance, and determining what system to use based on hazard application. This month's meeting presentation will discuss clean agent systems so I would like to provide additional information that may be of use in designing a typical system.

From Wikipedia, the free encyclopedia: Gaseous fire suppression is a term to describe the use of inert gases and chemical agents to extinguish a fire. This is also called "Clean Agent Fire Suppression". These Agents are governed by the NFPA Standard for Clean Agent Fire Extinguishing Systems - NFPA 2001 in the USA, with different standards and regulations in other parts of the world. The system typically consists of the agent, agent storage containers, agent release valves, fire detectors, fire detection system (wiring control panel, actuation signaling), agent delivery piping, and agent dispersion nozzles. Less typically, the agent may be delivered by means of solid propellant gas generators that produce either inert or chemically active gas.

What is NFPA 2001?

This standard contains requirements for total flooding and local application clean agent fire extinguishing systems. It is intended for use by those who purchase, design, install, test, inspect, approve, operate, and maintain engineered or pre-engineered gaseous agent fire suppression systems so they will function as intended when needed.

What does NFPA 2001 address?

This document covers both halogenated agents and inert gases and includes general information on applicability of clean agents, uses and limitations, hazards to personnel, electrical clearances, environmental factors, and compatibility with other agents. Requirements address components, system design, local application systems, marine systems, inspection, maintenance, and training.

Happy April!

We are still waiting for the official release of the codes updates for the state of Illinois Plumbing code and for the NFPA.

The NFPA changes to note are ones that in particular will affect the space allocated for the fire pump.

In the water service piping for the Fire Protection System there are elbows, tees, crosses, and code required backflow prevention devices that produce an imbalance in the fire pump water supply. The fittings change the plane of the flow relative to the plane of flow through the fire pump, causing low performance. NFPA 20 limits the location and arrangement of such fittings in the suction piping. New requirements call for these fittings to not be installed within 10 pipe diameters of the suction flange, and that the velocity on the pipe should not exceed 15 ft/sec. to maintain a constant laminar flow.



Another new NFPA 20 requirement is that access to the fire pump room and the location of the fire pump be preplanned and coordinated with AHJ. In addition, it is required that an enclosed passageway from an enclosed stairway or exterior exit doorway to the pump room be provided for those pump rooms that are not directly accessible from the exterior of the building.

The 2013 edition has been revised to require that the passageway possess the same fire-resistance rating as is required for the pump room: 2 hour fire rated if it is not protected by sprinklers and only one hour fire rated if it is fully sprinkled. If the fire pump room and passageway were constructed as a single directly connected area, then the passageway would essentially become a part of the fire pump room and would only be required to be separated with the same fire resistance rating as that required for the fire pump room. Note that additional provisions on this subject pertain to high-rise buildings. Therefore, get ready to request more space for your Fire Pump room and access path.

GUEST COLUMNIST: CPD EXAM PREP



TO BE CPD!!!

Of course *work* is important! Where would we be without it? But, right now, YOU need to focus on passing this test! You can do it!

Top 10 Tips For the CPD Exam:

10. Sleep!

Get plenty of rest the night before the exam. Eat breakfast and hydrate!

9. Arrive early!

This will take some of the pressure off! Pack everything the night before. Don't forget your calculator! Bring your ID's! Relax! Breathe! You can do this!

8. Know your calculator!

Practice with the exact same calculator that you will take to the exam. Make sure it is nonprogrammable, and eligible for use in the exam.

7. Know how many minutes you have per question.

Then watch the clock and try to gauge your progress. Try to recalculate this (simple calc of dividing the minutes left, by the questions left) to re-calibrate your time available per question as time goes on.

*In this case, you have about 2 minutes per question. Some will take less than 2 minutes, but some will take more. You can "bank" some extra time by picking off the low hanging fruit.

6. Do not leave any blanks!

As you approach the end of the time limit, open questions will diminish in number. As you get down to the final minutes, you must **make sure that every question is answered**, whether you know it right or not! **You get no points for blanks!** If you don't know the answer, and time is running out, just guess!

5. Make sure you convert all units. BEWARE OF UNITS! They can really trick you!

Units are often switched in the questions. Make sure you are using the correct units.

4. Double-check all calculations, at the end, IF you have time!

3. Know your reference material!

Most of your time could be wasted searching aimlessly for the right source to answer your question. You will receive a booklet for the exam. It will contain formulas and other tools. Skim through it first. You may find some values were given to you so you do not waste time trying to calculate things that you were already given.

2. Do a quick skim through the questions.

This will let you see anything that pops out as "easy" for you. Just "drifting around" will waste precious time, so do a QUICK scan! It you need more than a few seconds to know if any question is one of the "easy ones", skip that question! Then come back and repeat looking for the next level of difficulty. Repeat this process until you complete the test.

And the number one thing that will help you prepare for the CPD exam is...
