

a) Definition of a class III commodity has changed regarding the amount of plastic that could affect the amount of weight and volume of the items, which could determine the commodity being categorized into a higher classification.

2. 5.6.3.4 Class IV

- a) Table A.5.6.1.1 Guide to Identifying Commodities- New table has been introduced in the annex
- b) Table A.5.6.3 Alphabetical Listing of Commodities the table has been expanded and corrected on the impact of how todays commodities burn
- c) Table A.5.6 Commodities not addressed Indicates the and the expanded items or commodities that are not classified as class I-IV Group A Plastics.

The above-mentioned criteria is just an outline to the many changes that have occurred in the update of the new 2016 NFPA 13 code.

More approved amendments to the 2014 State of Illinois Plumbing code here are a few that became effective in the month of February 2016

Village of Plainfield

Ordinance Number 0216-815-0005:

All new water services shall be copper type K, and 1"dimaeter minimum.

Type M copper piping is not allowed for any potable water piping distribution system, underground, or overhead. Full port valves are required on each side of the water meter, a drain down valve shall be also installed before the second valve of the water service meter valve assembly.

Ordinance Number 0216-815-0006

Storm drainage from roof, paved areas, courts, and subsoil from or adjacent buildings shall be connected to storm sewer, (if available). Subsoils drains on the same lot shall be connected to the Sanitary sewer system within the lot lines.

Ordinance Number 0216-815-0007

All basements or building structures below grade at foundation shall be pumped up to an overhead drainage system.

Ordinance Number 0216-815-0009

All Grease interceptors for Restaurants shall be installed outside and made of non porous materials.

Ordinance Number 0216-815-0010

All new Plumbing Fixtures and irrigation controllers installed after Feb 11 2016 shall bear the "WaterSense" label.

Village of Roselle

Ordinance Number 0116-630-0039

All new Plumbing Fixtures and irrigation controllers installed after Feb 03 2016 shall bear the "WaterSense" label.

Village of Burr Ridge

Ordinance Number 0216-815-0007

After August 1 1990, all new buildings, or building additions, having basements or building structures below grade at foundation shall have overhead drainage system to connect to sanitary sewer facilities. No occupancy permit shall be issued for any building, or addition commenced subsequent to August 1 1990.

(This is kind of weird, therefore If you have a building at this village built within this period and the building basement goes out by gravity contact their local officials to clarify if the drainage needs to be redirected. You can contact <u>dar-rah.dunlap@illinois.gov</u> or call 217 785 2065.
