



#### For those who have their CPD Renewal Coming up this April

I just went through my CPD renewal process and thought I would share some notes. The ASPE certification expiration dates are as follows: CPD's expire April 30th CPDT's expire October 31st

24 hours of education in total are required to recertify your CPD/CPDT. ASPE's certification portal is now tracking Continuing Education Units, (CEU's), as "points". 1 CEU, or 1 Professional Development Hour, (PDH), = 10 points. So you would need 240 points, (i.e. 24 hours), of training to renew.

At least 50% of the training, (120 points or 12 hours), must be from ASPE, (through ASPE the Society, via ASPE Chapter Technical Meeting OR ASPE approved course from an ASPE approved provider). CEU's from the ASPE Chicago Chapter Technical meetings are automatically being added to your ASPE education account as of September 2019, (we used to email these to you).



Note that these will be reviewed by Society staff and the Credentialing Committee and will therefore hold up your recertification timeline – ASPE SUGGESTS YOU SUBMIT THESE WELL IN ADVANCE OF YOUR CPD/CPDT EXPIRATION DATE: <a href="https://education.aspe.org/CPDRecertExternal">https://education.aspe.org/CPDRecertExternal</a> <a href="https://education.aspe.org/CPDRecertExternal">https://education.aspe.org/CPDRecertExternal</a>

The CPD/CPDT recertification review process can take 5-10 BUISNESS days. DO NOT wait until 4/30 to recertify, especially if you plan on submitting external/non-ASPE approved training CEUs/PDHs such as chapter meetings from prior to September 2019!

THE FOLLOWING SCREEN SHOTS AND STEPS ARE INTENDED TO WALK YOU THROUGH ON HOW TO CHECK THE AMOUNT OF ASPE APPROVED TRAINING YOU CURRENTLY HAVE OBTAINED. This is only valid for CPDs due to recertify by April 30, 2020. CPDs due April 30, 2021 and CPDTs will not appear there yet, but hopefully in early 2020 you'll receive information from Society regarding this.






Happy New Year Chicago Chapter Members!

It's hard to believe we're into a new decade, but the 20's are here, which means it's time for me to struggle with writing dates again! I hope everyone had a fantastic holiday season. It was great to see so many people at Booster/Casino Night! Based on the noise coming from many of the tables, it sounded like everyone was having a lot of fun! We cannot pull this great evening off without all of the great support we get from our affiliates and the efforts of our VP Affiliate, Darren Rich! Thank you!

#### Codes - To Change or Not to Change

Illinois Plumbing Code: For 2020, it appears that Illinois may not be getting the revised plumbing code we were expecting when the newsletter went out last month. On December 17th, the Joint Committee on Administrative Rules (JCAR) held their meeting where the 2nd Notice Text was to be reviewed for possible adoption. I was not able to attend this meeting due to work commitments, however, based on information I gathered, JCAR spent a brief period of time on the subject and requested that the public comment period be extended. One could only assume that this is due to the large number of responses that were received in response to the 1st Notice and likely the 2nd Notice. By extending the comment period, the committee killed the proposed changes, which were set to expire on January 2. 2020. The committee requested that IDPH include all the stakeholders in the code change process on the next go around. I'll keep you up to date for any future action that may need to be taken since it appears that the code change process is going to start over, hopefully with less controversy.

Last month, I included a link with IDPH's responses to the comments they received on the 1st Notice Text. ASPE submitted comments on the proposed revisions, but those comments were not included in the official response document that was issued by IDPH. ASPE has since received responses from IDPH, who referred ASPE to responses made on similar comments. ASPE has requested that their comments be included as part of the official record. Chicago Plumbing Code: As you may have seen advertised by ASPE, a full day workshop is being offered on the new Chicago Plumbing Code (Title 14P) on April 3, 2020 at ASPE Headquarters in Rosemont, IL. The workshop is being presented ASPE Chicago Chapter's very own Julius Ballanco. There is no information available at this time regarding what changes to expect and how much of the International Plumbing Code will remain intact once the adoption process is complete.

There is also no information available on whether the public will have an opportunity to comment on any proposed amendments to the International Plumbing Code.

Fire Protection - Residential Buildings in Chicago: As of January 1, 2020, sprinklers will be required in all new residential buildings with 4 or more dwelling units, regardless of the old or new building code.

Alternative Plumbing Materials Pilot Program: The Chicago Department of Buildings recently announced that this program has been extended to July 31, 2020. August 1, 2020 is the date in which the new codes are to become mandatory, so one could assume that the new code will incorporate some of the materials that have been permitted as part of this program.

If you are not familiar with the program, this is a program allows the use of alternative plumbing materials and methods for drainage pipe, vent pipe, and pipe fittings that are authorized for such use by the Illinois Plumbing Code as long as your application has been approved. The eligible projects are restricted to the following:

New construction of buildings of exclusively residential occupancy, not more than four stories in height Any work in an existing building (constructed prior to 2010) of any occupancy, and not more than four stories in height, including additions to such buildings.

As a continued reminder, the new Chicago Building Code (Title 14B) is now available for purchase and can be viewed online for free here <a href="https://codes.iccsafe.org/search/?search=Chicago">https://codes.iccsafe.org/search/?search=Chicago</a>. Pay special attention to the fire portion of Title 14B, which is substantially different than the current code.

Please note that the new code is now optional for all new permit applications and will become mandatory for all permit applications started on or after August 1, 2020. For any new projects in the City of Chicago, be sure to verify which code the Owner or Architect intends to apply under.
