Another draft of the upcoming Chicago Plumbing Code has been provided by the City to our ASPE Chicago VP Legislative for our review/comment. Past Chapter President/ Current Chapter Historian Joe Ficek and I gave some input on the city's first draft to the Plumbing Code. If anyone is interested in reviewing this draft to propose changes, please reach out to the board! #### ASPE Chicago Chapter Looking for IL Professional Engineers willing to Contact the IL State Board to push for a Plumbing Specific Depth Module:

For those unaware, the ASPE Professional Engineer Working Group is trying to push for a Plumbing Specific depth exam module as developed by the National Council of Examiners for Engineering and Surveying (NCEES) and administered by the IL State Board of Professional Engineers. (note this is not a Plumbing specific PE, but still would fall under the Mechanical PE license). Currently, I would argue, that the 'Fluids and Thermodynamics' depth module is the closest thing to 'Plumbing' that we have, (as opposed to 'HVAC' and 'Machine Design' depth modules).



#### **VICE PRESIDENT, LEGISLATIVE**

Greetings Chicago Chapter Members!

I hope this newsletter finds you and your family in good health! I'm not ready for the cold weather that is starting to make itself known to the area.

First off, congrats to our own Jason McDonald and his election to the ASPE Society Board of Directors as Vice President, Membership at the first Virtual ASPE Business Meeting held this past month. Ja-

son's dedication and enthusiasm for ASPE cannot be surpassed, and we are lucky to have him as part of our crew!

#### City of Chicago Updates

#### Chicago Plumbing Code:

As I have mentioned in previous newsletters, the effort to adopt the International Plumbing Code has been delayed until sometime in 2021 when the City of Chicago Building Department intends on convening a group of stakeholders. In the interim, the Building Department is recommending amendments to the current Chicago Plumbing Code as an effort to coordinate with the 2019 Chicago Building Code (Title 14B) and stimulate the local economy. Unfortunately the earliest the amendments will be put in front of the City Council is in November after months of drafts and discussions. The ASPE Society Legislative Committee and Chicago Chapter have both contributed to the amendment draft process and continue to offer support as needed.

Below, please find a list of proposed interim amendments provided by the Chicago Department of Buildings (DOB):

1. Align requirements for minimum number of plumbing fixtures with the International Building Code.

Formulas for determining the minimum number of plumbing fixtures required for different types of buildings and businesses will be updated based on the same model code used to update the Chicago Building Code in 2019, reducing confusion and the need for variances.

2. Recognize additional materials and methods for drain pipes based on cost and performance data from 2-year pilot program.

Several types of plastic drain pipe materials will be allowed for use underground and in buildings up to five stories above grade. For larger buildings, with enhanced fire-safety requirements, several additional methods of joining metal drain pipe will be recognized. These changes are expected to provide significant cost savings and equivalent performance based on data obtained from the pilot program run by the DOB since late 2017. 3. Align requirements for protecting sewer system from grease with national standards.

Requirements for pre-treatment of grease-laden waste from commercial food service establishments will be updated to reflect the latest technical standards, allowing businesses to comply by using off-the-shelf products. Requirements for the use of catch basins in multi-family residential buildings, which are not based on current science, will be eliminated.

4. Adopt provisions for optional all-gender restrooms.

Single-user toilet room signage requirements will be updated based on recent changes in Illinois law and optional provisions for all gender restrooms with private toilet stalls and shared sinks, based on best practices recently adopted in Denver and Vancouver, will be incorporated.

5. Recognize additional methods for venting based on model plumbing codes.

Designers and builders will be given additional options for configuring plumbing waste and vent systems, which have been shown in a national study to provide significant savings for residential construction and renovation work.

#### 6. Clarify requirements for water-conserving plumbing fixtures.

Inconsistent water usage requirements for different types of plumbing fixtures will be clarified based on federal regulations and previous legislation that requires new plumbing fixtures to be certified under the EPA's Water Sense program, where applicable.

#### 7. Strengthen and clarify requirements to protect drinking water.

Chicago's commitment to enforcing lead-free standards in new plumbing will be restated in clearer language while methods allowed for joining copper pipe and connecting faucets and appliances to the building plumbing with short lengths of flexible hose will be clarified.

#### 8. Update standards for plumbing fixtures, consistent with latest national standards.

Minimum standards for plumbing fixtures such as faucets, toilets, and showers will be updated to reflect the latest national product safety and performance standards, so that newer products are fully recognized without confusion or the need for variances.

#### Align Requirements for Public Swimming Pools with 2014 Illinois Department of Public Health (IDPH) Regulations.

Provisions that are inconsistent with state swimming pool regulations adopted in 2014 will be eliminated. Provisions for private residential pools (not regulated by the state) will have inconsistent provisions removed.

#### 10. Streamline administration of trade licenses.

DOB will be given full responsibility for licensing and disciplining both plumbing contractors and drainlayers. Plumbing contractors will be authorized to perform drain repair without a separate license.

#### Chicago Building Code:

#### Lead Service Pipe Replacement Program:

Last month, Mayor Lightfoot announced a plan to replace the approximately 380,000 lead pipe water services within the City of Chicago to begin in 2021 pending ordinance approval from the City Council in November. Participation in the plan is voluntary and there are a couple forms of financial assistance available to the homeowner. Unfortunately, there does not appear to be any financial assistance if the service replacement is part of a home renovation project. #### **Interesting Local Code Requirements**

Have you ever come across an interesting, obscure, or odd local code requirement on a project? The types of requirements that seem to rear their heads at the worst possible time, resulting in an embarrassing and costly resolutions. Coincidentally, not long after the board discussed this possible member benefit, I came across unusual requirements in Aurora, IL that are not found in their Illinois Plumbing Code Amendments. Instead, the requirements are found in their amendments to the 2015 International Building Code as follows:

2801.1.1 Natural Gas services for New R-2 apartment buildings:

Shall be served with an independently metered service per dwelling unit.

2901.1.2 Domestic water services for New R-2 apartment buildings:

Shall be served with an independently and privately metered service per dwelling unit.

Per a conversation with the City of Aurora, the gas meters are required to be utility meters, but the domestic water meters are required to be sub-meters with a single city meter serving the multi-family building.

Always read through all the local amendments to be sure you do not miss anything. It is also good practice to call the local authority early on to discuss a project and try to find out if there are any code requirements you should be aware of. Do not forget to check out the Illinois Code Official Directory located in the "Members Only" section of the <a href="Chicago.ASPE.org">Chicago.ASPE.org</a>

Please reach out to me if you have any code questions, code updates, ideas for topics of discussion, or you are looking for any interpretations and I will try and include pertinent information in future newsletters.


