

<u>Title of presentation</u>: Corrosion Management for Fire Sprinkler Systems

#### Presentation Summary:

This presentation discusses the science of corrosion in fire sprinkler systems. The benefits and practical application of using Nitrogen Gas to inert Wet Pipe, Dry Pipe and Preaction Fire Sprinkler Systems to prevent and manage internal corrosion. Under a nitrogen atmosphere, oxygen corrosion, which is the primary cause of corrosion related failures in sprinkler systems, can be completely controlled resulting in reduced risk (life safety, leak and business continuity), enhanced performance, and extended life of the fire sprinkler system. Discussions will include:

- Understanding the operation of nitrogen generators
- Inspection testing and maintenance of nitrogen generators
- · Reducing corrosion in wet pipe sprinkler systems
- Eliminating oxygen corrosion in wet pipe sprinkler systems using wet pipe nitrogen inerting (WPNI) protocol.

#### Presenter Bio:

Bill Aaron - Director of Training at Engineered Corrosion Solutions.

Bill has worked in the fire protection industry for over thirty years with experience in installation, project management, consultation, inspection, installation, and design of fire protection systems. Bill has obtained a certification in Fire Alarm Systems from National Institute for Certification in Engineering Technologies (NICET) Level IV, served on the NICET Board of Governors, and is a past chairman of the NICET Board of Governors. He served as a member of the National Fire Protection Association (NFPA) technical committee for NFPA 2 and NFPA 720. He also served as a member of the National Society of Professional Engineers (NSPE) Board of Directors and the NSPE House of Delegates.



Bill has been educating engineers, sprinkler contractors, sprinkler fitters and property managers through ECS University and educational lunch-and-learn sessions since 2017.



Greetings Chicago Chapter Members! Hope you had a great holiday season!

#### City of Chicago Updates:

Air chambers are making a comeback to code! For those of you who aren't a fan of water hammer arrestors, then you must be very excited for this. For those of you who trust in the reliability of our arrestor manufacturers and dislike how air chambers fail, it might be good to share reasons why the air

chambers came back to code. Risk and liability. You and I are all aware of these terms. Installing a new product in the city on a mass scale has a set of problems that need to be worked out.

- 1. PDI-WH201. This installation guideline is both straightforward but also a little confusing if it's your first time reading it.
- 2. Inspectors may not have the expertise with hammer arrestors, so locations and quantities would be tough to inspect being a "new" product.
- 3. Access panels. Most our of specifications say to install an access panel in front of hammer arrestors. The manufacturers (that I've talked to at least) say you don't need an access panel because they last 50 years, but if you are required to have one then the manufacturers say to install the arrestor behind drywall or above a ceiling.

These are 3 things that need to be sorted through. It's my belief that air chambers will be illegal in the future, but both chambers and arrestors are legal in this current transition period.

If you're not familiar with what risk and liability are, meet me at Moretti's this month and I can share a story or two!

## Three design aspects I want to discuss:

1. How cost conscious are you? After you size a system, say a water heater. Do you systematically upsize the selection to the next heat exchanger?

It's always a great thing to have equipment in place that will properly serve the occupants of the building you've helped design, right? Often times, this means oversizing so that occupants don't have a lack of the utility in question, such as your water heaters and booster pumps.

## **VICE PRESIDENT, LEGISLATIVE, CONTINUED...**

I'd love to discuss water heaters as a talking point today. Say your rule-of-thumb water heater sizing calculations (as can be found in the ASPE Design Handbook Volume 2) indicate you need 217,000 BTUs of water heating. Do you upsize to a 249,999 BTU heat exchanger? Or do you give the time to review options? Can the heater be a 199,999 BTU heat exchanger?


I can see on projects with a small amount of design time systematically getting the larger heat exchanger, but did you know many of our rule-of-thumbs oversize the system already? In these sizing guidelines, it says lavatories use 5 gallons per hour. But the lavatory's flow rate is less than 0.5 GPM. Does it make sense that lavatories are used anywhere near 10 minutes per hour? Maybe that one lavatory next to the paper towel dispenser does, but if there are more, the other lavatories are often neglected. That's just one example, but I would ask that you consider the background of the rule-of-thumbs we use to size our systems. And I'll leave you with a question, do you know the gallons per hour impact the water heater storage tank size gives to your hot water system?

2. How do you annotate utility connections to each fixture in your design drawings? Do you place 4 annotations on the floor plans at each fixture? Do you rely on schedules?

Annotations are necessary to uphold the integrity of our designs. But I've noticed some drawings can go too far, and I fear this can (accidentally) lead to mistakes. It's best to show information in one place, and one place only. For starters, I've opened drawings for a project having over 100 fixtures, each fixture was tagged and accompanied by four pipe tags informing of the cold water, hot water, vent and sanitary sizes to be provided at each fixture. That is over 400 pipe tags that could be removed from the project! If you stay with me, I can share a couple examples of what I do to avoid this busy work to generate cleaner drawings.

In the first image below, we are presented with a classroom with four sinks in it, one sink is in an enlarged plan but the other three are clearly annotated on this floor plan. Notice how there are few pipe sizes shown? We probably want the water lines into the classroom to be a 1", but the branch lines are 3/4" with a 1/2" roughed-in under the sink. The mains are annotated off the image, but the branch lines are not sized here. The branch lines are scheduled, as we can see in the second image, to indicate the water size to be routed to the fixture, and the size of pipe roughed-in, along with sanitary and vent.

Does this look helpful or lazy to you? I'd love to discuss! I have found once I made the switch to this approach, I'm down to zero RFIs about the size of pipe needed to a scheduled fixture!



In this next image, I have shared a floor plan with no water supply branch piping over these patient rooms. Crazy, right? But what happened on this project was that there were about 60 rooms typical to these shown. So early on I wanted to be creative and show our work one time, in one spot and not repeat the work 60 times in a typical manner. So we fit out one room to a level of development (LOD) to nearly 300, created an isometric of it and referred all 60 rooms to the single isometric. Looking back, I'd have liked the water lines to showers to be 1" instead of the 1-1/4" we see.

Have you ever done something like this? Are there other examples you have of gaining efficiencies by getting creative?



#### 3. Do you prefer trap primers or trap seals?

Both primers and trap seals are legal in Chicago. Primers require a water connection and continually supply water to a p-trap so the sewer gasses are separated from the occupied space by the water seal in the p-trap.

Trap seals, however, require no water and achieve the same level of separation between occupied air and sewer air. You may ask, but which one is right for me? I'm still trying to work this one out myself, but generally speaking I try to use the ASSE 1072 trap seals every chance I get to save on construction costs. In sensitive areas, or in areas that might not get much foot traffic but can get debris into a floor drain, I use trap primers. The ASSE 1072 rating requires trap seals to be able to handle solids, but chunks that get caught between the flaps keep the flaps open and sewer air can bypass.

If rooms in my projects are sensitive in the sense of healthcare, central sterile or otherwise and there won't be much waste water then first I'd try to remove the floor drain. But if it must stay, then I might go with an electronic trap primer so the trap primer doesn't need to be installed adjacent to a water closet to activate and keep the water seal in the p-trap.

Where are you at with your use of trap seals and trap primers?

What do you think? I'd love to have a discussion about any or all of these opinions, I'm here to learn and to share what I'm learning.

Make it a great 2023!


